No Set-Ups allowed in Day of Show Parking Lot

The time limit in the unloading/loading areas is 15 mins. With no exceptions. Day-of-Show parking will be **\$20.00** per parking space. No vehicles requiring more than one space (motor homes, oversized vehicles or trailers etc.) allowed in the Day-of-Show or Overflow parking lot.. No overnight parking will be allowed in the Day of Show parking lots.

Shuttles are primarily for people, not dogs or equipment.

Towing Policy- Anyone not following KCPS rules risks having their vehicle towed at owners' expense.

Cars parked in the unloading zone will be towed without any public announcement. If a vehicle is towed the owner can contact Plaza Towing to reclaim their vehicle 760-775-4314

TRANSFERS - The Deadline for Exhibitors wishing to transfer their dogs is at the Superintendent's table 30 minutes prior to regular classes at that event.

ATTENTION EXHIBITORS

- The use of Flexi-leads is not permitted on the show grounds, except in the Obedience warm-up ring
- Flexi-leads are not allowed on the show grounds during show hours.
- All grooming is to be done in provided areas away from the rings.
- No unattended soft crates will be allowed on the show grounds.
- All power-driven convenience devices used on the show grounds must display a KCPS certificate of proof of insurance. Other power-driven mobility devices (OPDMD) as defined by the ADA are exempt from KCPS certification.

HOW TO COUNT POINTS

For complete Conformation Championship requirements, see **Chapter 16** of the *Rules Applying to Dog Shows* at akc.org

The Points toward a Championship shall be awarded to the Winners Dog and Bitch of each breed or variety based on the actual number of dogs or bitches competing in that breed or variety.

If the dog designated Winners Dog or Winners Bitch is also awarded Best of Breed or Variety, the dogs of both sexes that have been entered for Best of Breed or Variety competition and that have been defeated in such competition, shall be counted in addition to the dogs that competed in the regular classes for its sex in calculating championship points

If the dog designated Winners Dog or Winners Bitch is also awarded Best of Opposite Sex to Best of Breed or Variety, the dogs of its own sex that have been entered for Best of Breed or Variety competition that have been defeated in competition for Best of Opposite Sex, shall be counted in addition to the dogs that competed in the regular classes for its sex in calculating championship points

After points have been computed for Winners Dog and Winners Bitch subject to the above two stipulations, the dog awarded the Best of Winners shall be credited with the number of points calculated for Winners Dog or Winners Bitch, whichever is greater. If no points are available for the Best of Winners, the number of regular class dogs in both sexes are added together and compared to the point schedule. If the total sum of regular class dogs and bitches meets or exceeds the number of competitors needed for one point in its sex, the Best of Winners will receive one championship point.

In counting the number of eligible dogs in competition, a dog that is disqualified, or that is dismissed, excused or ordered from the ring by the judge, or from which all awards are withheld shall not be included. Any dog which shall have won fifteen points shall become a Champion of Record, if six or more of said points shall have been won at two shows with a rating of three or more championship points each and under two different judges, and some one or more of the balance of said points shall have been won under some other judge or judges than the two judges referred to above.

For schedule of points corresponding to this dog show, please see breed heading in the catalog.

How to Count Grand Championship Points at AKC Dog Shows

A dog must be (1) a Champion of Record or (2) have been transferred to BOB competition based upon the owners' records of their having completed the requirements for a CH title to be eligible for Grand Championship (GCH) competition.

The American Kennel Club requires a dog to obtain a total of 25 points with three major wins (a major win is worth three points or higher) to become a Grand Champion. The majors must be won under three different judges and at least one other judge must award some of the remaining points – so you need to win under at least four different judges. Also at least one Champion of Record must be defeated at three of these shows.

Best of Breed – BOB; Best of Opposite Sex – BOS
Select Dog – SD; Select Bitch – SB

Remember, point schedules vary by show location. If you are not at the show, make certain you get the points schedule for the event region where your dog won. Refer to the *Schedule of Points*.

The Grand Championship points awarded are determined by the same divisional point schedules that are used for the calculation of championship (CH) points.

Check the posted copies of the judge's book before you leave the show to make certain your dog was marked correctly. Mistakes do happen! Also, verify that your dog's AKC registration number is correct in the catalog. If it is not correct, let the superintendent know before you leave the show. In both cases, it's easier to make the correction on the day of the show rather than later.

How To Figure Points If Your Champion Dog or Bitch Goes Best of Breed

Grand Championship points will be calculated according to the number of dogs *competing* in the regular classes, as well as dogs competing in Best of Breed competition.

A dog awarded BOB will be credited with the number of GCH points calculated for BOB or BOS whichever is greater.

TIPS: (Effective 11/1/17) Veteran dogs or any other non-regular class dogs are counted in determining points. All eligible entrants from non-regular classes can earn Grand Championship points. Any Champion dog from the regular or non-regular classes is not considered for the requirement to defeat at least one Champion of Record at three shows.

TIPS: When counting dogs in competition, you only count dogs present that are judged. Dogs that are disqualified, dismissed, excused, absentee or have all awards withheld do not count.

How To Figure Points If Your Champion Dog or Bitch Goes Best of Opposite Sex

If the Judge elects to award GCH points to his BOS winner, we count all dogs of their sex competing.

How To Figure Points for Select Dog or Bitch

Now we move on to Select Dog and Select Bitch. These are new AKC terms created for use in the Grand Championship program. Here we count all dogs of the same sex except BOB or BOS in the Best of Breed and regular classes. Once again, it is entirely at the judge's discretion to choose a Select Dog and/or a Select Bitch.
